**JUDGMENT AND ORDER OF
PERMANENT INJUNCTION**

1. Defendants’ Cedric Nouwezem and Marlene Nouwezem default has been entered after service of process. The Court held a default judgment hearing on November 26, 2013. Plaintiff has elected statutory damages under 17 U.S.C. § 504(c). Plaintiff is also entitled to injunctive relief pursuant to 17 U.S.C. §§ 502 and 503. In its discretion under the statute, the Court awards total damages, which includes attorney fees, of \$5,000.00.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that Defendants Cedric Nouwezem and Marlene Nouwezem and their officers, agents, servants, employees, attorneys, and those persons in active concert or participation with them who receive actual notice of this Order by personal service or otherwise, are hereby permanently restrained and enjoined from:

- A. Directly or indirectly infringing Plaintiff’s rights in the Video “Maximum Conviction”;



- B. Using the internet to reproduce, copy, distribute the Video “Maximum Conviction”, except pursuant to a lawful license or with the express authority of Plaintiff;
- C. Retaining any copy of the Video “Maximum Conviction” and any copies of it transferred onto any physical medium or device in each Defendant’s possession, custody, or control.

IT IS FURTHER ORDERED that each Defendant also shall destroy all copies of the Video that Defendants have downloaded onto any computer hard drive, server, or other storage medium without Plaintiff’s authorization, and shall destroy all copies of those downloaded audiovisual works transferred onto any physical medium or device in each Defendant’s possession, custody, or control, and shall provide proof of such destruction to Plaintiff.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Plaintiff Voltage Pictures, LLC, have judgment against Defendants Cedric Nouwezem and Marlene Nouwezem, jointly and severally, in the principal amount of FIVE THOUSAND DOLLARS AND ZERO CENTS (\$5,000.00), inclusive of reasonable attorneys’ fees, with interest on the unpaid balance from the date of this judgment at the rate of 0.14%, compounded annually.
